- **c.** Financial Report and Updates
 - i. Discussion/Possible Action: Q1 2024 Financial Report Financial Director Gabe Buldra stated we started off with \$2,803,596.62 in total assets. After contributions from the District, the State, and payouts, it results in a net decrease in fund balance of \$91,502.40. After investment income and direct expenses, that resulted in a net of \$98,222.86. That increased our total fund balance to \$2,810,317.08.

- e. Pension Benefits
 - i. Discussion/Possible Action: Draft Pension Board Bylaws

The bylaws have been updated to reflect the most recent statutes regarding groups that may be eligible to be on the pension board. The bylaws now state that the regular board of directors may assume authority for the pension board if nobody from the eligible groups steps forward. Legal recommended that each year the department should reach out to each group to let them know there is an opportunity to be on the board and see if there is any interest.
